Overview of the Department of the Arabic Language

Among the pioneers of the department are Prof. Dr. Ahmad Al-Najdi, Prof. Dr. Abdul-Hussein Al-Mubarak, Prof. Dr. Mustafa Abdel-Latif Jiawok, Prof. Dr. Muzhar Al-Sudani, and others.
