- 1) The research should be specialized in Iraqi and Basrah matters, past, present, and future.
- 2) It should follow the known research outlines, concerning the quoting and documentation, in addition to clarity and correctness.
- Not published or to be published in other journals.
- 4) It presented with two abstracts, Arabic and English, each in no more than 10 lines.
- 5) The title of the research, the name, the academic title, and the academic institution of the researcher printed in Arabic and English in a split paper.
- 6) Margins and references listed at the end of the research.
- 7)All researches are presented to a specialized juries and linguistic evaluators, asking the researcher to write a commitment to make the proposed corrections.
- 8) The research presented in three printed copies on (A4) with its (CD).
- 9) The arrangement of the researches in the journal is submitted to technical regulations of the journal itself, not to the research or the researcher position.
- 10) The researches, published or not returned to their owners.
- 11) The statistic schedules, the charts and the maps presented separately from the text on( A4) papers, with a reference to the number of the schedule or the shape. It is necessary for these charts to be clear for the easiness of reprinting process.
- 12) In order to attain a publication admission, authors must pay publication fees in advance, ID 75,000 per Paper (no more than 25 pages per paper). Authors are subjected to an additional charga of ID.2,000 for each extra page.

#### **Publishing Ethics**

- •Arabian Basra Studies Journal adopts rules of confidentiality and objectivity in the arbitration process for both the researcher and readers (arbitrators). It transmits each research which is arbitrable to authorized evaluators within the precise scientific field of the research in order to assess it according to specific points. In the event of a discrepancy between evaluator, the journal would depend on another weighted evaluator.
- •Arabian Basra Studies Journal adopts on reliable and experienced readers in their specializations.
- •Arabian Basra Studies Journal adopts on accurate internal organization which is clear in its duties and responsibilities in the work of the editor and its hierarchical functioning.
- •It cannot be for editors and readers, except direct charge about the editing process (editor-in-chief or his representative), to discuss the research with anyone else, including the researcher. Any distinct information, or any information has been obtained through reading should be secretly retained. And no one may be used those information for personal benefit.
- •In the light of readers' reports, the journal offers technical, systematic and information support service for researchers as required and serves to improve the search
- The Basra Studies Journal committed to inform the researcher about acceptance of the research to be published without modification, or in accordance with certain amendments based on the reading reports, or apologizing for not publishing with stating the reasons.
- •The Arabian Basra Studies Journal committed in quality of audit, editorial, printing and electronic services that offered for research.
- •Respect for the rule of non-discrimination:

- •Evaluates editors and reviewers the research material according to their intellectual content considering the principle of nondiscrimination that based on race or sex or religious belief or the political philosophy of the researcher, or any other form of discrimination, except compliance with rules and regulations and the
- language of scientific thinking in showing and introducing of ideas, trends and topics in addition to discuss or analyze them.
- •Respect the rule of non-conflict of interest between editors and researcher whether it is result of competitive, cooperative or other relationships or links with any another researcher, companies, or institutions that related to research.
- •The Basra Studies Journal committed in not using of any of its members or editors the unpublished material which research contains in their own research.
- •Intellectual property rights: the journal has the intellectual property rights for articles published. It is not allowed to be reproduced in whole or in part, whether in Arabic or translated into foreign languages, without express written permission from the journal.
- The Basra Studies Journal fully committed in getting permission of the foreign journal when using translated articles and respect for intellectual property rights.

#### **Evaluators Guide**

The main task of a scientific evaluator, of the researches for the publishing, is to read the paper which is in his/her scientific field very carefully and evaluated according to a vision and an academic perspective which is not subject to any personal opinions. Then, deciding his/her notable and sincere remarks about the addressee paper.

Before starting the assessment process, the evaluator should make sure it is fully prepared to evaluate the addressee search and whether the research is located within his/her scientific specialization or not? Does the evaluator has enough time to complete the evaluation process? Otherwise, the evaluator can apologize and propose another evaluator.

After the evaluator's approval on conducting the evaluation process and be makes sure that (s)he is able to complete evaluation during the specified period, the evaluation process must be done according to the following parameters:

- Evaluation process must not exceed ten days so that it does not affect negatively on the researcher.
- Non-disclosure about the search information for whatever reason during and after completion of the evaluation process unless after taking a linear authorization from the researcher, or the editor-in-chief of the journal, or when the research was published.
- Do not use the search information for any personal benefit, or for the purpose of causing harm for the researcher, or his /her sponsoring institutions.
- Disclosure any potential conflict of interest.
- Considering the principal of not affecting by nationality or religion or gender of the researcher, or any another personal considerations.
- Is the research authentic and important so much so that it must be published in the journal?
- Does the research agree with the general policy of the journal and its publishing controls therein?

- Does the idea of the research find in previous studies? If yes, please indicate those studies.
- Does the title of the research agree with its content ?
- Does the abstract of the research describe clearly its content and idea?
- Does the introduction of the research describe what the researcher wants to access and clarify it accurately? and whether the researcher explained it the problem which (s)he studied
- Does the researcher scientifically and convincingly discussed the results that (s)he found during his research.
- The evaluation process must be conducted secretly and without any informing of the researcher about any aspect of it.
- Editor-in-chief must be informed first, If the evaluator wants to discuss the research with another evaluator.
- It should not be there any direct communications and discussions between the evaluator and the researcher with regard to the research under evaluation process. The evaluator's notes about the research must be sent through the editor-in-chief of the journal.
- If the evaluator found that the research is taken from previous studies, the evaluator must state those studies to the editor-in-chief of the journal.
- The scientific notes and recommendations of the evaluator will be mainly depended on them in the decision to accept the search for publication or not. The evaluator is also requested to clearly state paragraphs which need a simple adjustment as possible to be carried out by the editorial board and to those paragraphs that need a substantive amendment which must be done by the researcher himself/herself.
